General Information –

Each Festival weekend, as part of the popular **Afternoons in the Atrium**, national and international choirs present short performances back to back from 2pm to 6pm on Saturday 21st April and Sunday 22nd April in the laid back and informal atmosphere of the Clayton Hotel. This year we are also delighted to welcome back our **Emmet Place Food Market** where a **Festival Stage** will be programmed with Choirs throughout the same weekend. Finally, and throughout the Festival, international and national choirs will bring the city to life with song in our **Choral Trail**, with events happening across the city and county and all for free!

Application

Choirs who wish to perform in any of the non-competitive performances may fill out the application form overleaf. Deadline for all non-competitive applications: **Friday 16th February 2018**.

Afternoons in the Atrium: Choirs will be asked to prepare a 15 min programme of popular nature. A piano will be available on the day, however, due to limited space, rehearsals cannot be facilitated. Should singers however wish to warm up, choirs are welcome to do this in front of Clayton Hotel on the Lapp's Quay Board Walk. Please note that you will be contacted with regards to your performance time closer to the Festival.

Emmet Place Market Stage: Choirs will be asked to prepare a 25 min programme of a popular nature. Due to limitations on stage all pieces performed must be a capella. Due to the outdoor nature of the performance, rehearsals cannot be accommodated on site. Please note that you will be contacted with regards to your performance scheduled time prior to the Festival.

Choral Trail: Choirs will be asked to prepare a 15-20 min programme of their choosing. Due to the variety of venues and limitations in space, pieces should be unaccompanied. However, if accompaniment is needed, choirs must provide their own accompanist/instrument.
